Some things she has seen have concerned her regarding humans and equality. This is a confirmation, and not something the student body can elect. Because the Student Government Association is a representative of the student body, it must represent everyone.
      - e. Senator Sullivan: yields time to Dionne Meadows.
        - 1. She thinks that someone who is on the confirmation bill supports initiatives that are not inclusive to the Auburn Family. She states that he trivializes poverty and could not say that he would administer the position fairly. There needs to be empathy, understanding, and nonpartisanship.
      - f. Senator Devore: yields time to Mya Strickland, President of the Black Student Union.
        - 1. She is not confident in the approval of Stephen Morris as Chief Justice and is disappointed that the confirmation bill made it this far. She heard a comment made earlier today that was concerned about how Stephen Morris would handle a transgender person running for Miss Homecoming. Many people are watching this.

g. Senator McDonald: Asks for context on the tweets that have been mentioned.

h. Senator Belser: The code on confirmations does not specifically say the role of Senators for a confirmation. Cites the code regarding Senate impeaching a candidate; a legitimate reason to deny a candidate for a position is for any action that is unbecoming.

i. Senator Sullivan: Bringing up the code makes a good point, but he is concerned about the precedent it would set if this was struck down based on political beliefs. Cites the tweets that he was sent. Political views should not be considered.

j. Senator Turnipseed: Reads the role of Chief Justice in the code; political views do not have anything to do with the ability to uphold the role of Chief Justice. If a precedent was set upon political views, this would be very dangerous and it does not affect the responsibilities of the role.

k. Senator Turnipseed: yields time to Gwen Charles.

1. It is dangerous to vet candidates based on their political views. She would expect them to go through the Twitter for every other person pending confirmation; everyone has the right to say what they want to say, regardless of whether you agree with them. Stephen Morris is a student who can share his beliefs. View the candidate from an objective standpoint; everyone is nominated for a reason.

1. Senator Belser: To clarify, he was not trying to use political beliefs and does not want to call anyone out on their political stance. If anyone pending confirmation used the phrase "inhumane animal" to reference people, they are unfit to serve in any position in the Student Government Association. He encourages other Senators to remain non-accusatory.

m. Senator Dickinson: yields time to Mya Strickland.

1. She echoes what Senator Belser said and feels as if the topic is being diminished but it is just talking about human decency. There are many different types of people on campus, and they all matter and deserve representation. When controversial topics arise, they should be treated fairly.

n. Senator Harris: Cited a tweet from Stephen Morris as an example of non-bias. Neither side is right for standing to create bias. His Twitter is not purely leaning toward one side or the other.

o. Senator Seckinger: Inquires about the Code of Laws stating that a list of qualifications and duty of positions should be made available for each position a week before confirmation. She does not recall receiving this.

p. Senator Sullivan: If there is anyone who was a part of the selection process, he requests that they provide context on this point by Senator Seckinger.

r. Senator McDonald: Stephen Morris had the best responses to the application questions, had the best list of qualifications, and had the best interview.

s. Senator Williams: yields time to Jordan Denson.

1. Cited two counter-examples of biased opinions from Stephen Morris' Twitter against transgender people in the LGBT community. States that people have free speech but not

freedom from consequence. States that everyone must be catered to, and highlights that there are a lot of members of minorities present speaking against this person.

- t. Senator Sullivan: yields time to Stephen Morris.
  - 1. He wants to allow everyone to speak their opinions before he responds to the statements.
- u. Senator Williams: yields time to Dionne Meadows.
  - 1. The concept that hate speech does not exist is false; Stephen Morris cannot represent everyone well.

v. Senator Harris: There was no mention of race in Stephen Morris' tweet. There were people of all races involved in the Black Lives Matter movement; Stephen Morris did not specify race.

w. Senator Turnipseed: yields time to Allen Li.

1. He was on the Election Board, and objectively thought that there were other candidates that could fill the position of Chief Justice in an effective way to avoid controversy. He tried to be unbiased; there were concerns with Stephen Morris' ability to work with other people on the team and in the Student Government Association. He believes that wholistically, there was a better candidate.

x. Senator Williams: She is blown away by the passion in students' voices and states that everyone must remember that this is the Student Senate. It means a lot that students are coming and voicing their concerns; it is the duty of the Student Senate to vote in the best interest of the students.

y. Senator Devore: Thinking back on her time so far in the Student Senate, the Student Senate unanimously voted on a Resolution urging Auburn leadership to prioritize social justice and doing the best to help minoritized students. There are a lot of minoritized students speaking tonight. Just because something has been politicized does not make it political. These are issues of social justice regarding African-American individuals, those in poverty, and transgender individuals.
z. Senator Sullivan: yields time to Stephen Morris

- enator Sullivan: yields time to Stephen Morris
  - 1. America is all about free speech. He is happy that everyone is in attendance, and happy to defend himself.
  - 2. He is grateful for a high level of confidence from Student Government Association President Waggoner, will always apply the law, and will never insert personal beliefs. It is not his job to make the law, and he will faithfully apply the law if confirmed. The Judicial Branch should be free of partisanship. He has several ideas to improve the Judicial Branch, including increasing awareness of the Judicial Branch designed to benefit minoritized students, plans to travel to Montgomery to hear a case from the Alabama Supreme Court, and working with Dr. Brown to develop legal writing skills.

- 3. He will recuse himself to prevent any conflict of interest. In an opinion writing process, there must be legal reasoning and nothing can be said unilaterally. Everyone will be voting; he will make sure that everyone's voices are heard and that Associate Justices' questions are heard.
- 4. Listed qualifications, including serving as the Vice President of Best Buddies, Week of Service Head Counselor for the Honors College (the Week of Service theme is serving those that are impoverished), member of Mortar Board, member of Cardinal Key, member of Lambda Sigma, member of Freshman Forum, member of Lobby Board, Be the Creed Nominee (nominated by an African-American individual).
- 5. Took a Constitutional Law class and learned about law that relates to Civil Rights. He recently completed an internship at the Lee County Justice Center. He has had multiple conversations and interactions with Senator Belser; none of which have been derogatory.
  - a. Senator Belser: Point of order; asks not to be referred to by name.
- 6. Everyone should be defined by their character, not their race or income. He acts in a non-biased way toward other individuals. He cites an academic study from a liberal organization.
- 7. His view on abortion stems from a strongly-held religious belief. He had classes with transgender individuals and would never want to use an incorrect pronoun. He prefers to call people by their name (and respects if the individual has made a change to their name if they have changed their gender). He believes that God created mankind as man and woman.
- 8. He speaks on unprotected speech and protected speech, and cites Supreme Court cases. He believes that he is being discriminated against, and would be more than happy to debate outside of this meeting. The mission of the Student Government Association is to serve, promote, and unify. If this confirmation is voted against, there will be a dangerous precedent set.

aa. Senator Belser: Stephen Morris did not acknowledge his Twitter statement including "inhumane animals". It was allowed for him to interject during Stephen Morris' time speaking.

ab. Senator Belser: yields time to Molly Boudreaux
