I ask for the approval of the following:

### **CHAPTER 500** – Schools Council

**500.4.11** To collaboratively construct an email to the Dean of their respective college within the first two (2) weeks of their term in the Spring semester, and within the first two (2) weeks of the Fall semester.

**500.4.11.1** The email must include the required components set forth by the Executive Director of Schools Council as well as intentions to have a formal meeting to discuss the content of these components.
