Due to the COVID-19 pandemic and its effect on Auburn University policies and guidelines, the Student Senate will temporarily suspend Title X of the Code of Laws for the 2021 SGA and Miss Auburn election. I ask for the approval of the following:

700.2 The SGA President, in partnership with appropriate cabinet officials, will ~~conduct a competitive application process in order to~~ select students that most demonstrate the capacity and desire to serve their board or committee of interest. Selected students will then be recommended by the SGA President to the President of Auburn University for official appointment.

700.2.1 For a student to serve on a University Committee or Board, a student must maintain a minimum of 2.0 cumulative, unadjusted Auburn GPA, unless there is a higher-grade point requirement previously required by a specific board or committee. A student must also have been enrolled at least one semester at Auburn University prior to serving on a Committee or Board.
