Survey Design Tips:

- a. Survey: Asking open and closed ended questions to receive self-reported responses.
 - i. Responses can be opinions, actions, and observations.
- b. Use baseline cross project reporting demographics to shorten surveys.
- c. When wording questions make sure to ask one question at a time. Use clear terminology that students can understand and that does not elicit a specific desired response (leading questions).
- d. Make sure that your answer choices include all answers possible.
- e. Group related questions together and employ skip logic when possible.
- f. Include a cover letter or email invitation with your survey that informs students of confidentiality/ identification associated with the survey.
- g. To keep students motivated do not allow surveys to exceed ten minutes, send out reminder emails, offer incentives when appropriate, and provide feedback to participants about findings once the survey is complete.
- h. Make sure to keep your sample in mind when determining your approach.
- i. Refer to baseline support site for questions.
- j. Include a date/timeframe with your survey title.
- k. Take the U.S. 2020 census.
 - i. This is the first-time college students are asked to complete the census at their college residence rather than their parent's residence.
