- ii. Limiting concourse interaction to prevent harassment is not the best option. Concourse interaction exists to educate students, and many students who rely on concourse interaction would be left out if this aspect of campaigning were to be shortened.
- iii. There are concerns about moving voting to Friday since many students do not have classes on Friday which may decrease student participation.
- iv. Shortening campaign week to not include the weekends presents challenges for candidates' mental health.
- v. There is also a concern that this legislation strips power from the director of elections.
- vi. The biggest concern is that we did not see a lot of student feedback to support this legislation.

Questions and Responses:

i. Why does it matter that a lot of students rely on concourse interaction to get information since this interaction will not likely be possible with COVID-19.

This bill will not pertain to the spring. That is why it is concerning to decrease concourse days since we are hopeful that in the fall things will return to normal.

- ii. Why are there concerns about having voting on Friday? We feel that if voting is on Friday students will be less educated and less aware of voting. In addition, not having a weekend during campaign week would likely putting a lot of stress on campaign teams.
- iii. Why did you only now decide to bring up these issues instead of when this was a current or future order?These were discussions that I expected to happen on the senate floor.

Unfortunately, in my opinion, these conversations did not happen.

Debate:

a. Senator Christian: "On Friday, I had a conversation about the horrors of campaign week with someone during my office hour. I know that I had conversations and I have heard conversations. I have full faith that we did not gloss over a piece of legislation like this. One of the points that was brough up was that there was a lack of feedback. I am conflicted about this because I have also been hearing about survey fatigue. During the recess I talked to a lot of y'all about the conversations you have been having with people. I think that these campaigns give SGA a bad name. Another point is that we are supposed to be educating during the concourse hours. We do a lot of studying on paper, but what is on paper is not necessarily reality. We are not looking at the reality of the concourse because how often are you really being educated on the concourse. The reality is that we are not educating people on the concourse. What I am trying to get at is that we have a whole lot of support from students that cannot be seen on paper. SGA elections are something that students dread. SGA is not supposed to serve SGA, SGA is supposed to serve the students. However, the people who I have spoken to are likely not going to fill out a survey. There are a lot of people with very strong opinions who are not going to fill out surveys.

- b) Senator Dismukes: There has been some really good questions raised. With media being all week long instead of just during the formal campaign period, the bill that we passed would make media all week not just during formal campaign. The concourse is ideally meant for education, but we have to be honest that that does not really happen. Also, having voting on Friday would make run-offs a little easier and would allow campaign teams to rest. This legislation was meant to improve mental health. If a major candidate were to lose, the candidate would have the weekend to rest and recuperate. This was done for the students, not for SGA. There are three main concerns of Auburn students: dining, parking, and SGA elections. We have worked on the other two, and now for the first time we are working on SGA elections. There was no intent to strip power from Katherine. I think we can all attest to the fact that many people have been coming up to us and complaining about SGA elections.
- c) Senator Callahan: When I first heard this I was sort of against this because it was a major change to election week. But we can't stop election week and we can't stop concourse week. At the same time we need to address the fact that our current system is not in favor of the students walking on the concourse. It is said that we need concourse days because that is when the students become educated. We would all be naive to assume that students are being educated on the concourse and that nothing is happening on Saturday and Sunday during elections. Remember this was a unanimous decision by a group of people who were about to go through this process. I feel that our opinions are validated by that. Also I think there is a lot to be said about ending on Friday. I would like to make it very clear that I was very aware of constituents when I voted on this bill because I think that one week is a much more manageable time frame.
- d) Senator Locke: Can you clarify what the different voting means?
- e) VP Kassen: Voting yes upholds the veto. Voting no dismisses the veto.
- f) Senator Dorrill: I would like to clarify that this bill has nothing to do with this spring, correct?
- g) VP Kassen: Yes, we passed a bill a few weeks that threw out everything for this spring. This would go into effect in spring 2022.
- h) Senator Barrontine: Motion to adjourn.
- i) VP Kassen: Motion to adjourn does not carry.
- j) Senator Nobles: It never says that voting day has to be on Friday. Also, in reference to the COL it does not say anything about campaigning on the weekend. Could senator Dismukes or Senator Sullivan speak to this.
- k) Senator Dismukes: The director of elections could chose to have voting on Monday or any other day. It is understood that Friday would serve as the best day for elections. Senate would still have to approve the voting day.
