Yes, it is later in our term, but I'm not trying to pressure you guys to pass something through now. We still have time in our term where we can get good work done so we don't feel like we are starting over. We have an opportunity to get good work done and pick up where we left off. I will be okay if that happens. Do not feel pressured to get this done at last minute. I want y'all to think about: What problems are we trying to solve here? Would adding a seat solve that problem? Or, is it on us to be doing better in our respective roles? Senator Ward made a good point: it starts with us. We need to put more drive on the seats that exist. It's hard to argue for more seats if the current ones aren't doing their job. Can we be doing better, with more passion? Same with liaisons: can we be involving them more? We have a lot of room where we can be better. If we are doing our job to the best of our abilities, what problem are you solving by adding seats? Will that seat fix it? We want to include this entire room in that process. If we are going to do something, I want it to get done right.

- 6. Callahan, COSAM
 - a. We need to talk through the logistics of this. I was under the impression this was going to be future order this week.
- 7. Dismukes, Business
 - a. No, there is no legislation for this currently.
- 8. Callahan, COSAM
 - a. In regard to statement made about the 2/3 bill being the first step, I talked to many senators who were unaware that was part of the process. I spoke to Senators Groat, Ward, Lisenby, Christian...they were all unaware that was part of the process. I feel like if that was presented initially, we could have gotten better feedback for Bailey last week when she attended. We should have had a better conversation on the front end before we brought her in. We didn't have the full details. In regard to Honors College Seat, I believe there is not double representation. Like Gracie (Groat) said, every student here is undergrad NOT graduate. We cannot justify double representation under those pretenses. Senator Ward made a great point at exec last week: We will not have time in the spring to get this done. Many of us are running again and on prominent tickets. When Gracie (Groat) talked to Bailey, and relayed that conversation to me, Bailey wants to wait for Honors seat addition and wants to focus on liaisons. We need to spend more time thinking about Senate additions. It will set large precedent about what Senate will look like. Radical example: We don't have seats for the NRA in the U.S. Senate...we don't have special interest groups in our Senate. When will it stop? If we allow Honors a seat, how can we look at ISO and BSU and specific-interest orgs and say some have merit and some don't? I don't mean you can't have representation, but we don't want to leave the next Senate without a precedence. Honors already has enough representation.

9. M. Sullivan, At Large

- a. Cole (Callahan) makes a good point, we didn't make 2/3 bill clear enough. I made a whole presentation in August and at the beginning, I thought I'd made it clear. Basically, the presentation talks about Senate expansion and statistically how we can't currently fill positions. That's why we strayed towards 2/3 bill.

One thing to keep in mind with Honors College Seat: Are you taking away the value of other students' votes? Example: I can't vote for Honors, but I can vote for Business. Some of y'all are Honors students and can vote for both. Are we making sure every vote is equal, when some students have more opportunities to vote than others? Yes, the Honors College is a lot like an actual college here at Auburn structurally. But for example: If I live on the Alabama/Georgia border and I pay taxes to Alabama, and pay my water bill for Georgia, I don't get to vote for state senators for both. Yes we have Honors students that need representation, but we can't put spotlight on one group of students. By giving one group representation, what are we doing to make sure everyone else is represented? How will we keep Senate from being filled up to 100 seats? If we hand out Senate seats willy-nilly, when does it stop? I know we've had trouble filling seats, that's what we looked at with the 2/3 ticket and it was a great step. I would much rather have a group of 34 students that are 100% all-in, instead of 100 students who are half-in. This isn't a one-time fix; this sets a precedence for the coming years. College reports-what feedback did y'all get? There are two office hours for a reason. We have involvement and college hours. They're different for a reason. You're supposed to go into your college and sit for an hour and reach out or be reached out to. With COVID, we got relaxed. Two office hours, anything SGA relatedbenchmarking, meetings, etc. To say that Senate is not 100% all-in, I wish we were. I wish I had pages of feedback on the office hour form, but it never happens. I challenge you this week to get that feedback. Talk to constituents about grade forgiveness, what they want to see... If we want to create precedence, talk about adding seats, then we need to become all-in. We need to do our jobs like they're supposed to be done. I'm not going to run y'all down and say "This isn't enough feedback." Should I?
