4. To serve as student leaders and liaisons between students, faculty, and administration within SFWSCFWE.
5. To represent the school as representatives to the AU Student Government Association and other colleges and schools on campus.
6. To assist in the development of leadership skills for fellow students participating in the SFWSCFWE Student Government Association.

## Article III Membership

Faculty advisor membership overseeing SGA in SFWSCFWE shall consist of ~~one faculty member from any of the following areas: Director of Student Services, Wildlife Ecology and Management, Forestry, Natural Resources Management, Wildlife Enterprise Management, Geo Spatial Environmental Informaties or Sustainable Biomaterials and Paeking~~ the Student Services Coordinator for one year.

Student membership will consist of one Student President, Vice President, and Student Senator and all shall have voting power. Meetings shall be open to any School of Forestry and Wildlife Seienes College of Forestry, Wildlife, and Environment student, faculty member or member of the administration for one year.

Voting Selection – ~~Director of Student Services will recommend potential student leaders to serve in SFWS for the upcoming year who have exhibited leadership qualities and a solid academic record in SFWS. SSO Director will meet with students individually to discuss positions and responsibilities. Director will notify Academic Dean of students selected. Voting shall be open to all eligible CFWE students who meet the requirements and eligibility checks to run for these positions. Students who wish to seek a position of SGA within CFWE shall put their names on the AU involve ballot in the fall. Once the spring semester happens, CFWE students will elect who they feel best can serve the needs of the college in an open election.~~

## Article IV Officers

The Student Officers will take office and assume these duties during the spring semester of the academic year prior to the Student Awards Ceremony, so they may be introduced as new officers for the upcoming academic year.

1. The SGA President of the ~~School of Forestry and Wildlife Sciences~~College of Forestry, Wildlife, and Environment shall be the presiding officer over all student meetings. The SGA Vice President shall preside if the President is absent and unable to attend.
2. The SGA Vice President will be responsible for writing and developing announcements that need to be sent to Student Services so they may send out on the SSO List-Serve to the undergraduate student body. The VP is also responsible for posting information on social media and/or creating flyers to announcement SGA meetings or town halls.
3. The SGA Student Senator shall serve as the ~~SWFSCFWE~~ representative and attend all Auburn University campus Student Government Association meetings. The Student Senator also shall participate in all SGA officer meetings, as well as hold weekly office hours in the Student Lounge in the open area visible to students. Office hours will not be held in the ~~SWFSCFWE~~ Officer's office.

SGA President, Vice President and Senator shall:

- Represent the undergraduate student body as the official student leaders to serve and continue to create a collegial environment in ~~SWFSCFWE~~.
- Be expected to meet twice a semester and attend all SGA meetings called by the ~~SWFSCFWE~~ SGA President. In the event of an absence, the officer will be responsible for obtaining a replacement representative to attend.
- Shall represent the ~~School of Forestry and Wildlife Sciences~~College of Forestry, Wildlife, and Environment at appropriate Auburn University and community functions.
